Introduction

After the issuance of my 9/18/14 letter describing the code compliance condition of the structure that was based on member sizes noted on the original drawings dated 9/13/79 I was asked to make a site visit. The purpose of the site visit was to confirm or correct the sizes noted on the drawings and to check for any signs of settlement which would indicate that the footings were too small for the available bearing conditions. This site visit was made on October 1, 2014. Subsequent to this visit, the following amended report was prepared. Calculations are also attached. Beam numbers from the calculations are noted in the table below for correlation.

Evaluation

<u>Design Loads per 2012 IBC</u> Snow – 128 psf on the roof and open decks. Floor Live Load – 50 psf

Allowable soil bearing is 2000 psf unless a Geotechnical Report is prepared.

Corrective Actions

The following corrective actions are required to bring the structure up to the current load requirements of the IBC 2012 – 128 psf on the roof.

West Deck Joist (WB2)

Add (1) DF 2x12 to every other joist.

West Deck Joist Carrier (WB4)

A total of (3) 2x12 are required for the carrier beam (rim joist).

Roof Beam over Pool (WB7)

See the attached sketch.

North Roof Rafter (WB9)

Double each rafter. - (2) 2x10 @ 16" o.c.

Conclusions

The on-site inspection provided the needed specific span and member data to validate most of the structure in question. The above corrective actions should be implemented as soon as possible to bring the remainder of the structure up to code.
