Privacy Policy

This Privacy Policy describes how Island Park Village Resort (“we,” “our,” or “us”) collects, uses, and protects your information when you use our website

We are committed to safeguarding your privacy and ensuring transparency about how we handle your data.

1. Information We Collect

We may collect the following types of information:

A. Personal Information

you interact with our Services, we may collect personal data such as:

Name

Email address

Phone number

Mailing address

Payment details (for reservations, memberships, or event bookings)

B. Usage Information

We may automatically collect data about how you access and use our Services, including:

Device type and operating system

IP address

Browser type

Date/time of access

Pages visited and links clicked

C. Location Data

If enabled, our mobile app may collect your device's location to assist with tee time check-ins or navigation features.

D. Club Membership Information (If Applicable)

When provided by your golf or country club, we may collect details such as:

Member ID

Reservation history

Event participation

E. Health and fitness Data

- The app collects and processes limited health and fitness data only as necessary to provide core fitness and activity-tracking functionality.
- Subject to user consent, this may include workout and activity information such as activity type, duration, distance, time, calories burned, step counts, and activity status obtained from system health platforms, including Google Health Connect on Android and Apple Health on iOS.
- This data is used solely for displaying activity history, generating fitness insights, enabling in-app challenges, and supporting app functionality.
- Health and fitness data is not used for advertising, marketing, or profiling, is not sold or shared with third parties, and access permissions may be reviewed or revoked at any time through device settings.
- The app does not collect or process sensitive health or medical information.

2. How We Use Your Information

We may use your information for the following purposes:

To provide and improve the Services

To manage reservations and club activities

To personalize your user experience

To process payments and send confirmations

To communicate updates, promotions, and service notifications

To comply with legal obligations

3. Sharing Your Information

We do not sell or rent your personal information. We may share it in the following circumstances:

With your club or facility (for membership and booking coordination)

With trusted service providers that assist in operating our Services (e.g., hosting, payment processing)

As required by law, legal process, or to protect our rights

4. Data Retention

We retain your data only for as long as necessary to provide our Services or to comply with legal, regulatory, or club-related obligations.

5. Security

We implement reasonable administrative, technical, and physical safeguards to protect your information. However, no method of transmission over the internet or mobile networks is 100% secure.

6. Children's Privacy

Our Services are not directed to children under 13, and we do not knowingly collect personal information from them. If we learn that we have collected such information, we will take steps to delete it promptly.

7. Your Choices

You may:

Update your account information at any time

Opt out of promotional emails via the unsubscribe link

Disable location tracking in your mobile device settings

Request to access, correct, or delete your personal data by contacting us
